**REVIEW OF SYSTEMS**

Constitutional: Negative for chills, fatigue, fever, recent weight gain, recent weight loss, trouble sleeping, night sweats, electric shock, and heat exhaustion.

Musculoskeletal: Positive for neck pain, joint pain, joint swelling, and back pain. Negative for bruises, limited motion, fractures, arthritis, and prostheses.

Genitourinary: Positive for irregular menses. Negative for difficulty with urination, blood in urine, currently pregnant, and frequent urination.

Cardiovascular: Positive for chest pain. Negative for heart murmur, palpitations, swelling of feet, and arrhythmias.

ENT: Positive for hearing loss, difficulty swallowing, and ringing in ears. Negative for sore throat.

Skin and Breast: Positive for sores or blisters. Negative for swollen lymph nodes, psoriasis, rash, skin laceration, dermatitis, burns, abrasions, puncture wound, and needlestick.

Respiratory: Positive for cough. Negative for shortness of breath, mucus, and sleep apnea.

Gastrointestinal: Negative for abdominal pain, constipation, stomach ulcer, nausea, recent change in bowel habits, rectal bleeding, vomiting, reflux, and diarrhea.

Neurological: Positive for weakness. Negative for brief loss of consciousness, migraines, dizziness, headache, fainting, and numbness.

Endocrine: Negative for change in diet or appetite, excessive hunger, and excessive thirst.

Eyes: Positive for eye itching, blurred vision, difficulty seeing, eye pain, and corrective lenses. Negative for eye redness.

This occupational health record shows that my injury continued to be documented as work-caused and tied to unsafe conditions, yet the evaluation itself was requested, authorized, and framed by employer representatives and attorneys within the workers' compensation system. My attorney possessed and relied upon these records while confining the matter exclusively to workers' compensation and never explained to me that repeated employer-directed medical findings and attorney-managed causation implicated legal rights beyond that system. I reasonably relied on counsel to interpret and communicate the legal significance of these facts, and his control over the process prevented timely discovery of additional remedies, warranting equitable tolling.
